2. Town support of Bill no. 44: *An Act to bolster tobacco control.*

WHEREAS resolutions have been adopted by boroughs and cities in the Province of Quebec to ask the Quebec Government to subject the electronic cigarette to the same restrictions as imposed on

tobacco products, to review the *Tobacco Act* in order to extend the definition of public places and to adopt measures likely to prevent tobacco dependence in youth;

WHEREAS Bill 44 entitled *An Act to bolster tobacco control* was introduced at the National Assembly of Quebec on May 5th, 2015 by the Minister for Rehabilitation, Youth Protection and Public Health, Ms. Lucie Charlebois;

2015-10-217 THEREFORE, it is moved by Councillor Lynda Phelps:

THAT the Town of Baie-D'Urfé recognize that Bill 44 represents a major advancement in the fight for tobacco control;

THAT the Town of Baie-D'Urfé stress its support of the changes such as those subjecting the electronic cigarette to the same restrictions as imposed on tobacco products, those extending the definition of public places where the use of tobacco is prohibited to include restaurant terraces and bars, those prohibiting the sale of flavoured tobacco products and those prohibiting smoking in vehicles in the presence of youth under the age of 16;

THAT a request be made to the Quebec Government to modify Bill 44 so that the prohibition against smoking in public places also apply to children's playgrounds, sport fields and public beaches;

THAT a request be made to the Quebec Government to take on the packaging problem following the example of Australia and eventually Ireland and the United Kingdoms, asking for it to remain neutral; and

THAT a copy of the present resolution be transmitted to the Minister for Rehabilitation, Youth Protection and Public Health, Ms. Lucie Charlebois, and to Mr. Geoffrey Kelley, member of the Quebec National Assembly for Jacques-Cartier.

Prior to the motion being seconded, it is moved by Councillor Peter Fletcher, seconded by Councillor Brian Manning and UNANIMOUSLY RESOLVED to amend the motion in order to remove the second to last paragraph of the motion, which reads as follows:

"THAT a request be made to the Quebec Government to take on the packaging problem following the example of Australia and eventually Ireland and the United Kingdoms, asking for it to remain neutral"

WHEREAS the Town of Baie-D'Urfé (the "Town") is part of the Urban Agglomeration of Montreal;

WHEREAS on April 1st, 2015, an amended version of the Development Plan of the Montreal Agglomeration ("Schéma") came into force;

WHEREAS, according to section 58 of the *Act Respecting Land Use Planning and Development*, the Town must adopt any necessary concordance by-law within six months after the coming into force of an amended version of the *Schéma*, and, in this case, no later than October 1st, 2015;

WHEREAS a concordance by-law corresponds to any planning by-law or amendment to a planning by-law that is needed to take account of the amendment of the *Schéma*;

WHEREAS all the concordance by-laws must be submitted to and approved by the Montreal Agglomeration;

WHEREAS the Town has submitted its draft concordance by-laws to the Montreal Agglomeration in early August 2015 and the two parties are still discussing the required amendments;

WHEREAS, considering the ongoing process, it will be impossible to adopt concordance by-laws within the prescribed period, meaning before October 1st, 2015;

WHEREAS according to section 239 of the *Act Respecting Land Use Planning and Development*, the Town can ask the Minister of Municipal Affairs and Land Occupancy for an extension of time in order to properly complete the concordance process;

2015-10-230 THEREFORE, it is moved by Councillor Janet Ryan and seconded by Councillor Charles Colomb to request an additional period of 12 months to the Minister of Municipal Affairs and Land Occupancy, that is until October 1st, 2016, to adopt the concordance by-laws needed to ensure compliance of the Planning Program and the Planning By-laws of the Town of Baie-D'Urfé to the *Schéma*.
