Authorization to the Town Clerk to sign the Deed of Transfer for 21 rue Beechwood.

WHEREAS the property owners of 21 rue Beechwood and the Town of Baie-D'Urfé signed the Property Donation Agreement on July 6, 2016;

WHEREAS the Subdivision permit for lot no. 1 558 306 was issued by the Municipal Inspector, dividing the property into lot nos. 5 902 274 and 5 902 275; and

WHEREAS a notarized Deed of Transfer is required in order to transfer ownership of lot no. 5 902 275 to the Town;
