MAYOR'S REPORT ON THE FINANCIAL POSITION OF THE TOWN OF BAIE-D'URFÉ

Dear Fellow Citizens,

Although Bill 122, sanctioned on June 16, 2017 by the Québec Government "An Act mainly to recognize that municipalities are local governments and to increase their autonomy and powers" now abolishes the mayor's obligation to report on the financial situation of the municipality at least four weeks prior to the budget being deposited to Council for adoption, I chose to still submit my annual report for this year for the sake of transparency and in order to keep the citizens of Baie-D'Urfé informed. So I am proud to submit my annual report on the financial situation of the Town of Baie-d'Urfé for the year ended December 31st, 2016 and the projection for the year 2017.

2016 Year-End Results

The Town of Baie-D'Urfé's external auditors, *DCA Comptables Professionnel Agréés* inc. verified the Town's 2016 accounts and reported that the Town was in a solid financial position and that all our accounts were in order.

The 2016 audited financial statements were tabled at a meeting of Council held on May 9, 2017.

2016 Revenues

Total revenues for the Town of Baie-D'Urfé for 2016 were \$19 665 821, an increase of \$1 329 251 over budget. The main factors explaining the increased revenues are:

Property Tax Revenues (based on increased property values)	\$283 363
Property Transfer Taxes	\$910 483
Licences and Permits	\$35 682

2016 Expenditures

Total expenditures for 2016 were \$17 892 086.

Regional expenses accounted for \$11 349 419:

 \$147 805 which was paid to the Montreal Metropolitan Community (MMC) in membership fees and \$11 201 614 which was paid to the City of Montreal as our aliquot share for island-wide services.

2016 Surplus

The Town recorded a surplus of \$2 654 819.

This surplus is attributable to increased revenues of \$1 329 251, to reduced expenses of \$197 167 for projects that were not carried out and to lower expenses of \$662 710 (largely due to a reduction in: administrative expenses in salaries and employee benefits, expenses in building maintenance and repairs and expenses related to measures against the Emerald Ash Borer). The difference between the budgeted amounts and the expenditures for "building maintenance and repair" will be allocated to the building reserve fund and used for major building renovation work when required in future years.

As of December 31, 2016, the total accumulated unaffected surplus of the Town of Baie-D'Urfé was \$6 887 478. The Working Fund balance was \$958 730 and the Parks and Playgrounds Fund was \$48 214.

2016 Long Term Debt

Our long-term debt amounted to \$1871500 (down \$590000 from 2015). Of this amount, \$348152 (18.6%) is reimbursed by the Quebec Government, whereas the balance of \$1523348 (81.4%) is taxed to the residential and/or industrial sectors with \$1396022 taxed through local improvement taxes and \$127326 taxed at large.

2017 Projected Financial Results

The 2017 budget for the Town of Baie-D'Urfé was adopted at a special council meeting on December 13, 2016.

For the fiscal year 2017, the Town of Baie-D'Urfé projects an approximate surplus of \$1 900 000 over the 2017 tabled budget.

The projected revenues for 2017 exceed the tabled budget by \$1 100 000. The additional revenues are mainly generated from new taxation arising from renovations and new construction of buildings in the non-residential sector (\$928 630) and revenues of \$170 860 from increased water usage billing for the Industrial sector and an adjustment of water billing from Montreal for decreased water usage in 2016.

The projected expenditures for the fiscal year 2017 are about \$845 000 less than budgeted mainly due to the lower than anticipated costs for Emerald Ash Borer measures on the public domain (\$121 000), savings for building maintenance and repairs (\$192 470), and an adjustment reduction of our aliquot share to the City of Montreal (\$322 147).

General orientation for the 2018 budget

Council is very respectful of the citizens' ability to pay and prides itself in maintaining its position as the Town with the lowest tax rates on the Island, 12 years in a row since the demerger and is fully intending to make 2018 its 13th in a row.

We will continue to finance select projects from the Town's surplus as we did in the past few years.

The Agglomeration continues to be a very important factor in our overall budget since **73%** of all the property taxes the Town collect go to the City of Montreal to pay for our share of island-wide services.

We will have to wait for the City of Montreal's budget and what the Town's share will be before Council can determine what the final 2018 tax increase will be.

We expect that disputes over property assessments will be resolved, and a contingency amount will be included in the 2018 financial statements to cover possible taxation losses as a result of successful challenges.

The operating budget for 2018 and the capital expenditures program for 2018-2019-2020 are currently in preparation and will be tabled at a special council meeting in January.

With respect to another aspect of the Mayor's Financial Report relative to "Remuneration of elected municipal council members", it will be detailed in my June 2018 column of the News & Views as part of the new reporting required by the new Bill 122. Contracts involving an expenditure exceeding \$25 000 will be posted on our website by January 31, 2018.

I thank you for your confidence, once again, to serve as mayor of this incredible Town for another four years. I and the new Council are fully committed to working together for our community and our fellow citizens.

The voter turnout for our Town was quite impressive... 61.2% when most other cities on the island saw turnouts in the low 40's and 50's with one even as low as 35.1%!

During the election each member of Council did a lot of door to door visits and heard first hand from many, many citizens. We heard a lot about the growing concern over the construction of houses, popularly referred to as McMansions. People fear the character of the town is being changed by inappropriate development. We understand and will definitely respond to this concern.

We also heard about other issues – just to name a few – a need for improved communications, increased spending for Town infrastructure, better enforcement of Town by-laws, speeding concerns, and more access to recreational facilities. We completely agree that these are important issues, and we will be addressing them as we move forward.

We also heard that citizens would like us to stay the course on financial management — "pay as you go philosophy", low debt and low taxes — and to continue to use the Town's surplus to pay for large ticket items like the berm and Town infrastructure repair

(buildings, drainage, lighting).

But one other thing came across loud and clear, both in our conversations with our fellow citizens and in the voting itself: Baie-D'Urfé residents have overwhelmingly rejected the politics of accusation and division. They have voted for a democratic government — one that listens respectfully to all points of view, makes a decision based on majority vote and moves to get things done.

At the heart of democracy is compromise. If some people reject compromise, if each decision of the majority triggers endless acrimony, finger pointing and second-guessing, the system breaks down. It is impossible to please everyone all the time, because people have different priorities and points of view.

We will listen to and respect all opinions. And after weighing every option, we will do what the citizens of Baie-D'Urfé have elected us to do. We will make decisions based on what we believe is best for our town. Our decisions may not always satisfy everyone. But that is democracy. Everyone has a right to input and a right to vote. But in the end, a democracy must be guided by the will of the majority. You – our friends and neighbors – have voted for civil, democratic government. That is what we will give you.

Some of you have indicated an interest to participate in a more active way in the Town's democratic life by becoming committee members. In the next month, I will be visiting with councillors to determine the makeup of Council Portfolios and Town Committees and will be in a position in my February *News & Views* column to identify those committees that will have citizen volunteers as members. You will be asked to submit your candidacy for any committee that you would like to serve on.

Dear friends, we have the Council, the Administration, the financial resources, the passion and energy to move forward in a constructive and positive fashion to deal with the issues dear to you. The next four years look very promising.

Innovation at the CPE Whiteside Taylor

Last November, the Town proceeded with the installation of three (3) semi-buried containers at the *CPE Whiteside Taylor*. **One for garbage, one for recycling and one for organic materials** which will be reserved exclusively for the use of the CPE. Waste collection as a whole is an important element for the CPE staff as well as for the education of the children. What a beautiful example! Selected for their practicality, safety, robustness and aesthetic, these bins offer a solution to all problems related to vermin, health and safety.

Strategy Against the Emerald Ash Borer Follow-up

Citizens involvement for 2017 are summarized as followed:

- 5 citizens made a first treatment to their 27 ash trees and received **\$4800** in grants;
- 12 citizens made a second treatment for their 82 ash trees and received \$11,000 in grants;
- According to the number of trees already treated, these 12 citizens shared a total amount of \$4150 following a *TreeAzin* donation in 2016 made to the Town by *Tree Canada* in collaboration with *Bioforest technologies inc.*;
- Out of 25 ash tree felling permits, 6 citizens actually applied for a grant for a total amount of \$1470.

The Town of Baie-D'Urfé undertook during the month of October major repair work over a 400-meter portion of the service road in the Industrial Park which created traffic delays due to the closure of the entrance to the southbound service road and the required detours.

We want to thank all industrial park companies for their patience and understanding during these important repairs.

Furthermore, the project to modernize the street lighting network is well under way and by **December 15**th all of the lights in the Industrial Park will be converted to light-emitting diode (LED) technology and controlled by an intelligent management system. REMINDER - SMOG DAYS

The use of fireplaces and wood-burning stoves are prohibited during smog advisories.

SECTION 14.1

The use of a solid-fuelburning heating device



is prohibited when a smog warning issued by Info-Smog is in effect for the Montreal region, except when an electrical power outage affecting the Town has lasted for three hours or more.

SMOG WARNINGS

Smog warnings are issued by Environment and Climate Change Canada through the Info-Smog program at *canada.ca/en/services/environment/weather/airquality*. You can always consult our Baie-D'Urfé website to check the local air quality index through the *Citizen Services* tab.

SEASONAL REMINDERS

We remind you that it is prohibited to park any motor vehicle on public roadways during any snowfall of 2.5 cm or more as well as 6 hours following a snowfall. It is also prohibited, at all times, to park in the streets for a period exceeding 4 hours.
